MEASURE No 2/2018

of Transport Authority

of 7 September 2018,

determining the payments for access to railway infrastructure and service facilities

The Transport Authority pursuant to Section 53 (1)(a) of the Act No. 513/2009 Coll. on Railroads and on Amendments and Supplements to Certain Acts as amended by the Act No. 259/2015 Coll. (hereinafter referred to as "the Act") establishes:

§ 1

(1) This measure determines the payments for access to railway infrastructure within the scope of minimum access package and access to infrastructure connecting service facilities according to Annex 13, Part B of the Act, as well as the payments for access and services in the service facilities according to Annex 13, Part B second point of the Act of which the infrastructure manager is the sole operator.

(2) For the breakdown of payments for access to railway infrastructure within the scope of the minimum access package and access to infrastructure connecting service facilities and for the breakdown of the charges for access and services at service facilities of which the sole operator is infrastructure manager, shall be subject to a specific regulation¹). For the calculation of access charges railway infrastructure within the scope of the minimum access package and for access including track-side access to service facilities and services provided in these service facilities, the provisions of the special regulation is applied ²).

(3) For purposes of this measure shall be understood

a) a train according to the timetable, a train ordered to the new timetable or to the change of the valid rail transport timetable,

b) an ad hoc train, a train ordered outside the process of creating a rail transport timetable.

(4) The amounts of the payments according to Section 1 are provided in Annexes 1 and 2.

§ 2

This measure transposes the legally binding acts of the European Union listed in Annex 3.

§ 3 Cancellation provision

Decree of the Office for Regulation of Railway Transport of 2 December 2010 No. 3/2010 on determination of the payments for access to railway infrastructure (Notice No. 462/2010 Coll.) as as amended by Decree No. 7/2012 (Notice No. 156/2012 Coll.) is repealed.


